ORDER

In exercise of the powers conferred upon me under rule 34 (1) of Haryana School Education Rules, 2003, sanction is hereby accorded to grant permanent recognition to Cecil Convent High School, Ambala Cantt for class 8th to 10th under BOSE pattern with effect from 01.04.2007 on by Managing Committee, Balaji Educational Society, Staff Road, Ambala Cantt under following terms and conditions:

TERMS & CONDITIONS:

1. The school shall follow the syllabus of study as per syllabus prescribed by the official board.
2. The school shall charge fees and fines as applied to the appropriate authorities in the case of application for recognition and besides the sanction the notice board of the school and shall not increase the fee during the any academic session. In case of change in the fee structure, the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue proper receipt of fees/fines to the students.
3. Salary shall be paid as per declaration at the time of seeking recognition.
4. No recognition fee and other charges shall be charged from the children's parents.
5. School shall be open for admission without any discrimination based on religion, caste or race of both as any other school.
6. Managing Committee shall not allow to run two schools affiliated by different boards/boards in the same premises.
7. Managing Committee shall not allow down the school or do activities during the academic session without the prior approval of the appropriate authority.
8. The school shall be open for inspection for the inspecting officer authorized by the Director/Inspector authority.
9. Recognition so granted shall be renewed after every five years.
10. No financial assistance shall be granted by the Department to the school.
11. School premises shall not be used for commercial purpose and any National activities.
12. Approval of Managing Committee shall not be obtained from the appropriate authority in case of any change in the committee.
13. The Managing Committee shall follow the instructions issued by the Government/Department from time to time and supply the information to the Govt. Department as and when required.
14. Recognition so given to the Managing Committee shall be valid only in the case of Haryana School Education Rules, 2003 and its amendments if any thereafter. The Managing Committee shall be liable for all expenses incurred in case of violation of any provisions of the rules.
15. School will provide camp within six months after the recognition with status within two months of information, if any other school/center try to do the same the recognition will be revoked forthwith.
16. The number of students in classroom shall not be more than the students catered on the space per sq. student for secondary school. Senior Secondary Schools and 10 schools per sq. student for secondary school.
